# FLIPS & TUMBLES

## ANNUAL PASS; PAY WEEKLY

### INDIVIDUAL, 2x SIBLING, 3x SIBLING

---

#### Eligibility:

The Annual Pass; Pay Weekly Option is available to all customers aged 18 and older, or to minors with parental/guardian consent. Pass holders must have an active membership profile with Flips & Tumbles.

---

#### Payment:

The weekly payment amount is stated at time of purchase and is due each week until the passes annual term is complete.

- › Payments will be processed automatically every week via the payment method provided at the time of sign-up.
- › A valid payment method must be provided and kept up to date. Failed payments may result in suspension or cancellation of the pass and will incur additional Failed Payment fees.
- › If payments are late or declined, additional fees will apply.

Flips & Tumbles reserves the right to specify these fees and notify the pass holder accordingly.

---

#### Usage:

- › The Annual Pass grants unlimited access to: **Term Classes, Holiday Programme, Standard Kids Night Out sessions, Open Sessions, Holiday Workshops**, for the duration of the pass.
- › The pass is non-transferable and may only be used by the registered holder/s.
- › Bookings for classes or sessions must adhere to Flips & Tumbles' standard booking policies, including cancellation and no-show rules.

---

#### Cancellation & Refunds:

The pass may be cancelled at any time with two weeks' written notice to Flips & Tumbles.

- › Refunds will not be provided for weeks already paid, but access will remain active until the end of the paid period.
- › Pass holders who cancel their pass are still liable to pay the full amount for the remainder of the annual term.
- › Flips & Tumbles reserves the right to cancel the pass for misuse or failure to adhere to these terms and conditions.

---

#### Suspension:

- The pass may be suspended for up to 6 weeks in cases of illness, injury, or other valid reasons, with supporting documentation (e.g., a doctor's certificate).
- Suspension requests must be made in writing and approved by Flips & Tumbles management.

Flips & Tumbles reserves the right to update these terms and conditions. Pass holders will be notified of any changes at least 30 days in advance. Continued use of the pass after updates signifies agreement to the new terms.
